# **UPDATES FOR FUNDED ORGS**

## **Tier I Certification**

The Certification deadline for Tier I organizations is Friday, April 19, 2019.

Tier I organizations will provide certification presentations to the SCFD Board of Directors on Thursday, May 23 at Denver Zoo.



## **Tier II Qualification & Certification**



Tier II organizations must submit their qualification and certification reports by the following dates:

Tier II Qualification: 4 p.m. on Wednesday, May 22, 2019

Tier II Certification: 4 p.m. on Wednesday, July 3, 2019

The 2019 income threshold for all organizations to qualify for Tier II is \$1,695,039.78.

## **Tier III Grant Interviews and Allocations**

Following the successful submission of a Tier III grant application, be sure that you have scheduled your Tier III grant interview with the cultural council of each county in which you have applied.
