Tier III COVID status reports due Aug. 31

SCFD is asking Tier III organizations to submit their third online status update to keep SCFD informed of any changes your organization has made to its operations and programming in the wake of COVID for funding received in October 2020 that can be used through December 31, 2021. Apply Today for Leadership Arts 2021-2022

Celebrating 25 years in 2021, CBCA's <u>Leadership Arts</u> program is a nine-month training program that prepares people to serve on nonprofit boards of directors and increase their civic engagement in the arts. Leadership Arts 2021-2022 has a fresh dual-track, hybrid approach. Sessions will alternate between in-person gatherings at cultural venues and virtual classes for increased flexibility, accessibility and statewide reach. Participants can select the comprehensive program experience or an abbreviated virtual-only track. <u>Applications</u> are due by Friday, August 13. EARLY BIRD applications received by July 16 receive 10 percent savings on tuition.

Arts in Society Grants are open

Arts in Society is a collaborative grant-making program that fosters cross-sector work through the arts by supporting the integration of arts and culture into multiple disciplines critical to the health and well-being of Coloradans. The program, which is administered by RedLine Contemporary Art Center and funded through a cohort of Colorado foundations, provides grants ranging in size from \$5,000-\$35,000 to individuals and organizations who seek to implement projects that utilize the arts as an integral element in promoting social justice and community welfare. Submission deadline is September 14, 2021. You can learn more.
