### **Inclusivity Fund Advisory Committee**

As we enter 2019, the Inclusivity Fund Advisory Committee is entering its final area of work with the goal of beginning grant applications before the end of the year. The Inclusivity Fund, established during the recent SCFD reauthorization process, was established by the Denver Museum of Nature & Science, the Denver Art Museum, the Denver Center for the Performing Arts, the Denver Botanic Gardens and the Denver Zoo. In 2018, the Inclusivity Fund Advisory Committee selected Mile High United Way as the grants administrator for the fund. Current work includes efforts to put in place a framework for grant making from the fund.

### Tier III Final Grant Report

Any organization that received SCFD Tier III funding between October 2017 and September 2018, must complete and submit the Tier III Final Grant Report.

Organizations that do not submit a final grant report by this deadline will **NOT** be permitted to apply for Tier III funding during the 2019 grant cycle. There will be no exceptions.

The 2019 Final Grant Report is now available. Deadline: Friday, February 15, 2019 at 4 p.m.


