#### **Building a better mousetrap**

#### **County Cultural Council opportunities**

County Cultural Councils allow community members to engage directly with the art, science and cultural future of their community by helping to decide funding through the SCFD. Any community member can apply for a spot on a cultural council as long as they are a resident of the county to which they apply. Counties accepting applications for vacancies include:

<u>The Jefferson County Cultural Council</u> has two openings, one for a countywide representative and one representing county commissioner district 3. If you live in Jefferson County, <u>you are eligible to apply</u>.

- Application Opens: December 30, 2019
- Application Closes: January 15, 2020

The Broomfield County Cultural Council has five openings on its cultural council. If you live in Broomfield County, you are eligible to apply.

### **Denver's Minimum Wage Increase**

As we've mentioned before, <u>Denver is the first city to exercise its new</u> <u>authority to set its own minimum wage</u>. That new minimum wage -- \$12.85 per hour for all workers who don't receive tips and \$9.83 per hour for food and beverage workers who do receive tips – took effect on Jan. 1, 2020. This new minimum wage applies to all entities doing business in Denver, not just those entities based in Denver. Any organization that requires people to work more than four hours in one week within the City and County of Denver must pay those individuals the new minimum wage. <u>You can learn more</u>.
