As we enter 2022, SCFD's goal is to continue to support you to the best of our ability while staying true to our governing state statute to provide funding to "enlighten and entertain the public." WHAT YOU NEED TO KNOW

2021 PROJECTS

- Due to a large number of Tier III organizations relaying ongoing pandemic-related problems with completing funded projects, SCFD staff have determined a longer extension for the usage of 2020 funds is in order.
- The deadline to use funds received in October 2020 will now be December 31, 2022.
- All October 2020 funded organizations are expected to complete a 2022 Final
 Grant Report even if there were pandemic-related delays in the usage of funding.
 Please give the council thorough, but brief explanations of the delays and your plan
 to use the funds by the December 2022 deadline.

2022 PROJECTS

• For funds received in October 2021, the deadline to use the funds remains December 31, 2022.

WHAT YOU NEED TO DO

ATTENDANCE TRACKING & REPORTING REMINDER

Continue tracking in-person and virtual attendance. For virtual attendance- to the best of your ability - enter the location where the activity would have taken place or the location of the intended audience.

How to report attendance in the 2022 Final Grant Report (FGR)

Report on the organization's <u>in-person and virtual attendance</u> numbers for the most recently completed fiscal year.

• Include only virtual attendance that provides meaningful engagement.

Adult and Youth Attendance section

Account for a person's attendance in only one category

Attendance by County section

- Report attendance in the corresponding county based on where the participant resides.
 - When reporting on total attendance in the grant application, attendance is

based on where the program/event takes place. E.g., Ballet class taught in Broomfield County; assign all attendance numbers of said program to Broomfield County.

FGR REMINDER: Total Attendance must equal Total Attendance by County
